Financial Report 2024/25

After two years of reinvesting accumulated funds to improve the clubhouse and golf experience for its members, your Club Committee has overseen a surplus of \$18,672 for the 2025 financial year. Pleasingly, this was driven by a 10.8% increase in subscription fees, as we derived a full-year benefit from all the new members signed during 2024. The normalised result looks even stronger, once non-recurring items are added back:

This result was achieved even with a reduced contribution from bar operations, as we suffered from several washouts and public holidays falling on normal trading days. Bar prices were also kept in check, until the new container recycling scheme was introduced and prices inevitably had to be increased late in the financial year. Having said that, the bar remains very profitable.

Cash investments increased from \$183K at the end of June 2024 to \$212K at the end of June 2025. Given our not-for-profit status, the Committee will continue to identify improvement projects and it is clear that the club can continue to pay its debts as and when they fall due.

Cost of living issues continued to recede through 2025, but the CPI for Hobart still increased by 1.7% for the twelve months to 30th June. In May 2025, I advised the Committee that New Town Bay full members were paying only 9.5% more for membership fees than they did in 2018/19, while the CPI in Hobart had increased 23.5% during that same period. A recommendation was put to the Committee for a 5.0% increase to full membership fees in 2025/26 and 5.7% for 6-day members. However, no further increases will be applied to fees until at least 1 March 2027, as we move to the March-to-February membership year in 2026. The Committee approved these increases and membership numbers have remained steady, which is an excellent result.

Looking ahead to 2025/26, I have advised the Committee that I would like to step down as Treasurer after 9 years in the role. However, I do want to stay involved in club administration and have nominated as President for the new financial year. A more than suitable successor for Treasurer has been identified, and I hope to see him elected at the AGM. A new set of eyes in the office is bound to result in further improvements around the club.
